### SKI/SNOWBOARD STORAGE LOCKER AUTOMATIC RENEWAL TERMS & CONDITIONS

**Initial:** This contract is binding, and payment for year-round storage is due on the first day of this contract. I understand this storage contract will automatically renew every year on November 1<sup>st</sup>. If I choose to vacate my storage space(s) and cancel my automatic renewal, I must provide written notice to the Diamond Peak Ticket Office prior to the December 1<sup>st</sup> renewal deadline. By electing automatic renewal of my storage space(s), I agree to be charged the applicable rates annually. Diamond Peak Ski Resort will renew my storage space(s) and charge my credit card on file on or after November 1<sup>st</sup> and no later than December 1<sup>st</sup> each year for the same storage type I have elected under Section 1 of this contract. Rates are subject to change and the Diamond Peak Ticket Office will notify ski/snowboard storage locker holders of rate changes prior to the automatic renewal.

**Initial:** I understand it is my responsibility and I agree to update all changes to my credit card information on file with the Diamond Peak Ticket Office as they occur, by calling (775)832-1177. If automatic renewal charges cannot be processed because my credit card information has changed and I have not updated the Diamond Peak Ticket Office with new credit card information, I understand this could result in the removal of my name as the storage space(s) holder.

**I understand payment of my storage dues will be handled automatically, and I MUST have a credit card on file with the Diamond Peak Ticket Office (775)832-1177.**

## **SKI/SNOWBOARD STORAGE LOCKER TERMS & CONDITIONS – PLEASE READ, INITIAL, AND SIGN**

1. **Initial:** \_\_\_\_\_ I understand that IVGID and Diamond Peak Ski Resort are renting me a locker for the sole purpose of storing ski/snowboard equipment and clothing during the ski season.
2. **Initial:** \_\_\_\_\_ I understand that in order to rent a season locker, I, or a member of my immediate family, must have purchased a season pass for the current ski season.
3. **Initial:** \_\_\_\_\_ I understand that failure to renew my locker rental by the annual locker renewal deadline (December 1<sup>st</sup>) will result in the removal of my name as the locker holder and permanent reassignment of my locker to another.
4. **Initial:** \_\_\_\_\_ I understand that if I do not renew by the deadline, I must remove my lock and clear my locker before December 1<sup>st</sup> or I will be charged an additional \$50 fee, and all items in the locker will be removed and taken to Guest Services. (If still unclaimed after 90 days, all items will be donated to charity.) All outstanding balances on accounts must be paid before any season locker rental will be renewed.
5. **Initial:** \_\_\_\_\_ I understand that equipment stored in lockers during the offseason is only accessible by appointment. Appointments can be made by calling (775)832-1177 or emailing: ticketoffice@diamondpeak.com. All appointments must be during operational hours.
6. **Initial:** \_\_\_\_\_ I understand and agree that any loss, theft, or vandalism of personal property and the expense thereof as a result of my use of the locker is my responsibility and do hereby hold harmless the Incline Village General Improvement District (IVGID), Diamond Peak Ski Resort, their officers, agents, and employees from and against any and all claims, demands, or liability of any kind.
7. **Initial:** \_\_\_\_\_ I understand that wooden locker renters will be issued (1) key, available at the Guest Services window after opening day and may be copied by the renter. Additional/replacement locker keys will be subject to a \$5 fee.
8. **Initial:** \_\_\_\_\_ I understand that in order to renew a locker, my name must appear on the current Diamond Peak records as the locker holder. Rented lockers cannot be transferred or sublet to other individuals and I understand that doing so may result in permanent revocation of my locker privileges without refund.
9. **Initial:** \_\_\_\_\_ I understand that the locker area is not a secure area and can be accessed by other locker renters and the general skiing public.
10. **Initial:** \_\_\_\_\_ I understand that all rental lockers remain the property of the Diamond Peak Ski Resort and that the management of the resort reserves the right to suspend or revoke locker privileges without a refund.
11. **Initial:** \_\_\_\_\_ I agree to remove any perishable items from my locker prior to Diamond Peak's closing day. Any damage during the offseason is my sole responsibility.
12. **Initial:** \_\_\_\_\_ I agree the locker area shall not be used by the customer for any other purpose other than retrieving and replacing stored equipment, minimal time will be spent in the Locker Room.
13. **Initial:** \_\_\_\_\_ I agree that loitering, resting, eating, and drinking in the locker area will not be permitted in the Season Locker Room. For the safety of all locker users, failure to adhere to this policy may result in the revocation of locker privileges for the remainder of the season without a refund.
14. **Initial:** \_\_\_\_\_ I agree that signing this waiver gives the authorization to charge the credit card on my account.
